## **External Services**

#### Cloudflare

Club Penguin Atake uses Cloudflare's services to protect, secure, and block access to unwanted or dangerous networks, as well as to host our websites (except AS1, AS2, AS3, EP, PC, and PC3).

### Google Analytics

At Club Penguin Atake, we use Google Analytics to learn how users interact with our website. Here's how we use this information:

- 1. Behavioural Metrics: We collect behavioural metrics to better understand user engagement, such as which pages are visited the most, how long users spend on our site, and their navigation habits. This data allows us to improve our products and services by adapting them to user preferences.
- 2. Heatmaps and Session Replay: Heatmaps illustrate user activity by showing where they click, scroll, and spend time on our website. Session replay

- enables us to go over individual user sessions and discover pain points or places for improvement.
- 3. Site Optimisation: We analyse data to improve the performance of our website, ensuring that visitors have a flawless experience. By identifying bottlenecks or opportunities for improvement, we boost usability.
- 4. Fraud and Security: Google Analytics helps to detect suspicious activity and protects our website from fraudulent behaviour. To provide a secure environment, we monitor patterns and abnormalities.

GA4 does not record or keep IP addresses during data collecting. Instead, it uses them for geolocation during data collecting and then discards them.

### Microsoft Clarity

- 4. Privacy and Security: Clarity anonymizes IP addresses before storing data, ensuring that IP addresses are not saved or displayed in the reporting interface.

#### Gcore Labs CDN

Club Penguin Atake's content is distributed by Gcore Labs CDNs to help us shorten loading time and deliver everything smoothly for the entire world across all services.

When you request a file from a CDN hosted by Gcore, the service processes the following information:

- 3. referrer,
- 4. host,
- 5. Your Internet Protocol Address,
- 6. Your User Agent.

#### Short.io URL Shortener

Club Penguin Atake and its management and owner group Fullmoon utilise Short.io to shorten URLs and distribute them under the domains g.live.net.co, link.fullmoon.dev, l.tv.cpatake.boo, url.waddlepenguins.tk, r.waddlepenguins.me, and redir.igp.waddlepenguins.tk.

When you use one of these URLs, Short.io processes the following data:

- 1. Geolocation based on IP Address Country, City,
- 2. URL of the link that was visited,
- 3. Device information OS. Browser
- 4. Referrer
- 5. Campaigns
